- 3. Vistara reserves the right, at any time without prior notice, to add, alter, modify, all or any of these terms and conditions or replace, wholly or in part, this offer by any other offer, whether similar to this offer or not or to withdraw it altogether
- 4. The above-mentioned CV Points are for one-way Economy travel on Partner Airlines (Air Canada, Japan Airlines, Lufthansa, Singapore Airlines, United Airlines)
- 5. One-way Business class redemption ticket would be 4X of the Economy class CV Points mentioned above
- 6. One-way Premium Economy redemption ticket would be 1.6X of the Economy class CV Points mentioned above
